ASIER ALTUNA GARCIA DE SALAZAR was formerly a post-doctoral research fellow at the Centre for Irish Studies NUI Galway. Dr Altuna holds a PhD on the topic of 'Spain in Anglo-Irish Literature (1789–1850)' from the University of Deusto, Bilbao.

ARTHUR BROOMFIELD is a research student at Mary Immaculate College, University of Limerick, working on Maria Edgeworth's novels.

MARY BURKE was formerly NEH Keough Fellow at the University of Notre Dame, Indiana and is now assistant professor at the University of Connecticut. She is writing a book on the subject of the 'tinker' figure in Irish writing, and has published extensively on the subject of the depiction of travellers in Irish literature, including essays in *Études Irlandaises*, the *Australian Journal of Irish Studies*, *Travellers and their language*, *New voices in Irish criticism* 3, and *The Irish Revival reappraised*.

COLIN GRAHAM is a lecturer in English at NUI Maynooth. He is author of *Ideologies of epic: nation, empire and Victorian epic poetry* (1998) and *Deconstructing Ireland* (2001), and editor (with Richard Kirkland) of *Ireland and cultural theory* (1999) and (with Glenn Hooper) of *Irish and postcolonial writing* (2002). He has edited the poetry of Elizabeth Barrett Browning and Robert Browning and is currently co-editor of the *Irish Review*.

ANDREAS HÜTHER joined UL as a doctoral student in September 2000, having studied history at Mannheim, Durham, and Freiburg Universities. He was awarded the Scholarship in German of the Department of Languages & Cultural Studies for work on his thesis 'The Irish Celt: a nineteenth-century German construct?' He has compiled a bibliography of German publications in the field of Irish-German Studies for the *Yearbook of the Centre for Irish-German Studies*.

SIOBHÁN KILFEATHER is lecturer in nineteenth-century Irish writing at the Queen's University of Belfast. She was one of the editors of *The Field Day anthology of Irish writing, volumes 4 & 5: Irish women's writing and traditions* (2002) and has edited Maria Edgeworth's *Belinda* for Pickering and Chatto (2003). She is also author of *Dublin: a cultural and literary history* (2005).

JASON KING is a lecturer in the English Department at the National University of Ireland, Maynooth. He has published several articles on the nineteenth-century Irish novel, the Irish theatre, literature of the Irish diaspora, the Irish in Canada, the writing of Irish emigrants, and the representations of immigrants in Ireland.

LEON LITVACK is Reader in Victorian Studies at the Queen's University of Belfast. He is a past president of the Society for the Study of Nineteenth-Century Ireland, and editor of *Ireland in the nineteenth century: regional identity* (Four Courts, 2000). His publications are largely in the areas of nineteenth-century fiction (especially Dickens), art history, periodical culture, imperialism and post-colonialism.

PADDY LYONS works in the English Literature Department at the University of Glasgow, and is also visiting professor at the University of Warsaw. He has published largely in the fields of Restoration literature and literary theory, and is a translator of Louis Althusser.

PATRICK MAUME teaches in the Department of Politics at the Queen's University of Belfast. Among his many publications are *'Life that is exile': Daniel Corkery and the search for Irish Ireland* (1993) and *The long gestation: Irish nationalist life, 1891–1918* (1999).

LUCY McDIARMID is Carole and Gordon Segal Visiting Professor of Irish Literature at Northwestern University, Professor of English at Villanova University, and former president of the American Conference for Irish Studies. She has also taught in the English Department at Princeton. Her most recent book is *The Irish art of controversy* published by Cornell UP and Lilliput.

ALAN O'DAY is Fellow in Modern History, Greyfriars, University of Oxford. He has written and edited 30 volumes and published more than 40 articles. His works include *The English face of Irish nationalism* (1977), *Parnell and the first Home Rule episode* (1986), *Irish Home Rule, 1867–1921* (1998) and *Charles Stewart Parnell* (1998). His most recent volume, edited with D. George Boyce, is *The Ulster crisis, 1885–1921* (Palgrave-Macmillan, 2005).

GARY K. PEATLING is a joint University of Guelph/Institute of Ulster-Scots Studies Postdoctoral Fellow. He is author of *British opinion and Irish self-government, 1865–1925* (2001) and *The failure of the Northern Ireland peace process* (2004).

MARY S. PIERSE works in the Department of English, University College Cork, where she has taught courses on seventeenth- and eighteenth-century poetry, and late-nineteenth-century prose. A former Government of Ireland Scholar, she has also been IRCHSS Government of Ireland Post-Doctoral Fellow in the Humanities and the Social Sciences; her present research concerns Literary Impressionism in the writings of the Irish writer, George Moore (1852–1933).
