1. Welcome and Introductions

a) Conflict of Interest

b) Matters Arising

2. Epidemiological Assessment

a) Evaluation of Epidemiological data: (incorporating National Data Update, Modelling Report and International Update)

(i) Review of Epidemiological Situation in Kildare

The NPHET reviewed the current epidemiological situation nationwide, and specifically in Kildare. Regarding the epidemiological situation in Kildare, the NPHET noted that the situation continues to improve and is now broadly similar to that across the country. The NPHET considered the latest available epidemiological data; as of the midnight 29th August 2020 data were as follows:

Case Numbers

- The rolling 5-day average in Kildare is 10.8 cases as of 29th August 2020 (national is 113). This compares to a 5-day average of 22.2 cases in Kildare on 6th August 2020.
- In Kildare, 75 cases were notified in the week to 29th August 2020. This is 9% of cases notified nationally. This compares to 238 cases (44% of national) notified in the week to 8th August 2020, 170 cases (31%) in the week to 15th August 2020, and 159 cases (22%) in the week to 22nd August 2020.

Incidence Rates

- The rolling 14-day incidence rates in Kildare remains high compared to other counties at 105.2 cases per 100,000 population. However, this rate has been declining for the past 5 days. This compares to an incidence in the previous 14-day (2nd-15th August 2020) period of 183.4. The national 14-day incidence currently stands at 31.8.
- The profile of the disease in Kildare has been improving over the past 7 days in particular. Kildare's 7-day incidence on August 29th 2020 of 33.7 cases per 100,000 compares to a 7-day incidence of 57.6 on August 6th 2020. The national 7-day incidence is currently 16.8.

Modes of Transmission

• The number of cases attributable to community transmission or possible community transmission in Kildare over the past 14 days (16th to 29th August 2020) has been 36%. Nationally, the community transmission/possible community transmission rate also stands at 36%.

As the epidemiological situation both nationally and in Kildare are broadly similar there is no longer a rationale for a differentiated approach, noting that since the implementation of public health measures in Kildare on August 7th 2020, additional measures have been put in place nationally on 18th August 2020. While the epidemiological situation in Kildare has improved, the situation nationally remains uncertain and the impact of the national measures introduced on 18th August 2020 continues to be monitored closely.

The NPHET recognised the very significant impact of the measures on individuals, communities, and businesses in Kildare over the past 3 weeks and acknowledged that the improvement in the epidemiological situation there has been due to the willingness of everyone to adhere to the public health guidance and measures implemented.



The NPHET recommended that the public health measures in place in Kildare be aligned with those introduced nationally on 18th August 2020.
