# **OIREACHTAS UPDATE**

In Dáil Éireann on Tuesday afternoon, there will be a motion re the Social Welfare Bill 2014. Wednesday will see 4th Report of the Convention on the Constitution on the 'Dail Electoral System' brought to the forefront, whilst the Intellectual Property, Health Insurance, and Garda Siochana Bill's of 2014 will be discussed on Thursday.

On Wednesday evening, the Minister for Health will be discussing statements on Suicide and Mental Health with Seanad Éireann

In the Committee for the Environment, Community and Local Government, the agenda for Tuesday evening will be the approval of the terms of the Doha Amendment to the Kyoto Protocol.

# **WEB SUMMIT 2014**

Over 20,000 from over 100 countries came to Dublin to attend the Web Summit held last week at the RDS. The Web Summit is a technology and innovation led conference where many industry leaders from the world's largest companies attend alongside founders of start-up companies.

Amongst the speakers at the event included a diverse list of high profile attendees including Bono; executives from Fortune 500 companies; journalists from major internationally-renowned news outlets and magazines such as Forbes, New York Times, The Economist and Financial Times; Kevin O'Malley, the US Ambassador to Ireland; Annie Machon, MI5 whistleblower; and CEO's of international NGOs.

The event has been described as "Davos for Geeks".

# LETTERS BETWEEN BRIAN LENIHAN AND JEAN-CLAUDE TRICHET RELEASED

The exchange of letters between the late Brian Lenihan, the then Minister of Finance and Jean-Claude Trichet, the then president of the European Central Bank (ECB) have been released to the public. These letters were written in the run- up to Ireland's bailout by the Troika in 2010 and reveal the background to one of the most tumultuous events in Ireland's recent history.

These letters reveal that the ECB threatened to stop emergency funding to the Irish banking system unless Ireland took a bailout. Since the release of the letters, the ECB have denied they forced Ireland to enter the Troika programme, and that it was the domestic crisis in Ireland that led to the bailout.

# **REVENUE FROM TAX INCREASES**

The latest figures released by the Exchequer have shown that revenue from taxes have increased significantly particularly from stamp duty. Stamp duty has increased by 29% this year so far mainly due to rising house prices and the property market boom. Further revenue has come from tax on stock market exchanges, income tax and VAT. The boost in revenue from taxes has added €1.5 billion to the State's income. Exchequer figures have shown that the tax intake is 9% higher than at the same point last year. The reasoning behind this is people are buying goods and putting money back into the Irish economy and more people are entering the workforce.

# SUPREME COURT RULING ON SURROGACY AND BIRTH CERTIFICATES

The Supreme Court in a landmark case has ruled that a genetic mother is not the legal mother on a birth certificate when a child is born to a surrogate mother. In the particular case that brought about this ruling, the State had argued that a mother is a person that has given birth to a child rather than genetic links.

The Supreme Court has asserted that there needed to be clear legislation put in place in regards to this area. Following the ruling the Minister for Health Leo Varadkar TD said legislation on surrogacy, assisted human reproduction and gamete donation will be brought to the Government by the end of year.
