Oireachtas Update



On Wednesday in the Dáil the Social Welfare Bill 2014 will reach the Report and Final Stages.

On Tuesday in the Seanad statements are to be made on 'Government Geoscience Initiatives from Industry Support to Education'. The following day in the Seanad statements will be made on the 'Action Plan for Jobs 2014'.

Regarding Committee Meetings, on Tuesday the Joint Committee on Environment, Culture and the Gaeltacht will be scrutinizing EU legislative proposals, with representatives from Bord lascaigh Mhara and the Irish Seaweed Research Group from NUI Galway taking part. During that same meeting, the Minister for the Environment, Community and Local Government, Alan Kelly TD, will also be discussing his Department's future plans.

European Commission Investment Plan

The European Commission has announced plans of a public-private €315 billion plan for investment projects that is aimed to boost the European economy and create more jobs to get more people back into work in Europe. The Commission have already identified over a thousand projects for the investment plan. The investment plan will be composed of a €21 billion fund with €16 billion in guarantees from the EU and another €5 billion coming from the European Investment Bank. It is hoped that private investors will fund the additional investment.

The plan will be built around three main stages: the initial tranche will be the European Fund for Strategic Investment (EFSI); the foundation of a creditable project plan with a strategy to get investments where money is needed; and a strategic outline to remove regulatory bureaucratic red-tape and make Europe more attractive for investment.

European Commission approves Irish budget

The European Commission has approved and endorsed Ireland's budget for 2015. However, the European Commission have warned Ireland on its high level of debt. The EU believes that Ireland should be using its economic recovery to speed up the reduction of debt to Gross Domestic Product ratio. Furthermore, Ireland was found to be one of the five EU Member States fully compliant of the Stability and Growth Pact. The other four Member States fully compliant are: Germany, Slovakia, the Netherlands and Luxembourg.

All 18 euro zone countries budgets have been endorsed with the exception of Greece and Cyprus who are still in a bailout programme. However, the Commission has warned seven Member States that they are at risk of non-compliance with the Stability and Growth Pact. These Member States are Belgium, Spain, France, Italy, Malta, Austria and Portugal.

EU Parliament backs measure to split Google

The European Parliament has overwhelmingly backed a measure to split search engine services from commercial services. Members of the European Parliament backed the resolution with a resounding 384 votes for the measure to 174 votes against the resolution.

This resolution will heavily impact internet and search engine provider Google. Google dominates the internet search market in Europe, controlling over 90 percent of the market. However, the EU cannot force Google to break-up; it can pass anti-trust regulations as a next step which will force Google to re-evaluate how they operate and work in Europe. The EU has been investigating Google in an anti-trust inquiry since 2010.

In addition to this measure, Germany and France have asked the EU to consider implementing new competition rules that it would make it easier for to EU to regulate Internet companies.

Social Housing Strategy 2020: Support, Supply and Reform

The Government has announced a six-year social housing plan entitled 'Social Housing Strategy 2020: Support, Supply and Reform'. The premise behind the plan is to build 35,000 new social housing units that will come to the cost of €3.5 billion by the year 2020.

This plan will also establish a new housing assistance payment for over 75,000 households. This will be done in the aim that they will rent their homes in the private sector. 50,000 of the 75,000 households currently receive rent supplement. Thus, this new housing assistance payment is hoped to remove the barrier where people refuse employment because it would meant they would lose their rent supplement.

Alan Kelly TD, Minister of the Environment, Community and Local Government, has described 'Social Housing Strategy 2020' as the first comprehensive housing plan since 1995.
