Edel Creely has been named as the new President for Ibec, a group that represents Irish business.

Ms Creely is the Group Managing Director of Trilogy Technologies. She established the company in 2009, and they have become a leading IT Managed Services providers here, and have recently expanded into the UK.

She holds a degree in Engineering from Trinity College Dublin, served for a period as Chair of the Irish Software Association, has been a member of the Government's ICT Skills Action Plan for Jobs Steering Group, Enterprise Ireland's Advisory Group on Strategy for Software Sector in 5, currently serves on Enterprise Ireland's High Potential Start-up Advisory Panel. In 2as awarded a Fellowship of the Irish Computer Society, and the Tech Excellence IT Person of the Year in early 2017.

While speaking at Ibec's annual President's Dinner on Thursday evening, Ms Creely laid out what she believes are the current key priorities for business – tax, investment and Brexit. She also commented:

"Without decisive, assertive action we risk leaving a new generation struggling and, at the same time, dangerously undermining our country's attractiveness as a place to do business. We need to be more ambitious [and] more strategic".

Government Business: Bill for Irish Water refunds

This Wednesday and Thursday's Government Business will involve Second Stage disucssions regarding the Water Services Bill 2017. This Bill provides for the "discontinuing and extinguishing" of charges, and liabilities for those charges, that were imposed by Irish Water. It also provides for the refund of moneys paid in certain circumstances.

It will, in the stead of the charges, set a threshold amount of water provided to a household and establish a liability to pay when this threshold has been exceeded.

It will also establish two new bodies: the Water Forum (An Fóram Uisce), and the Water Advisory body (An Comhlacht Comhairleach).

On Tuesday, members of the Oireachtas will make statements on Brexit. This is following the visit of Guy Verhofstadt MEP, the European Parliament Brexit Coordinator, last week.

The Business Committee has allocated 15 minutes each for statements by Ministers, Minsiters of State, and the main spokespeople for parties and groups. All other members of the Oireachtas will be allowed 10 minutes to make statements, with an additional five minutes allowed for a response by the Minister or Minister of State.
