Dáil Resumes

Tomorrow, Tuesday 27 September, the 32nd Dáil resumes after their Summer Recess.

Considering the controversies abound with the Dublin Bus strike, NAMA's Project Eagle, the Apple ruling, and the closing Fiscal Space, the winter Dail term may prove to be a busy one.

Following some criticism of the slow pace of legislation to pass through the House, the Government will no doubt be eager to implement some of the measures outlined in the Programme for Government released earlier this year. Further, with Budget 2017 confirmed for Tuesday 11 October, all eyes will be firmly on members of the Government. This will be indicative of just how productive and cohesive the Partnership Government actually is, according to commentators.

The implementation of policy and legislation in the new political environment will be considered at a Public Affairs Ireland event next Friday 30 September.

Keynote speakers including the Government Chief Whip, Regina Doherty TD will discuss how policy and legislation can be advanced in the light of the radically changed political landscape. How will the minority administration secure the implementation of its policies and laws without having a majority in either the Dáil or Seanad. Other speakers will examine how minority Governments have secured the implementation of their legislative and policy agenda in other jurisdictions – with Dr Jim Johnston from the Scottish Parliament looking at the comparative experience there.

The Conference will also hear from leading experts in Politics and Government, regulation and public affairs.

Mahon Tribunal recommendations bear fruit

This Wednesday and Thursday will see Dáil Éireann's Second Stage debates on the Planning and Development (Amendment) Bill 2016. This Bill seeks to amend and extend the Planning and Development Bills 2000—2015.

It will also build on the recommendation of the 2012 Final Report from the Mahon Tribunal to create an independent planning regulatory body. The new legislation provides for the establishment of the Office of the Planning Regulator. Its role will be:

"to evaluate and carry out assessments relating to planning matters and provide observations and recommendations in relation to those matters, to conduct reviews and examinations and to conduct education and training programmes and research in relation to planning matters".

The Bill also provides for a new planning Framework, and will make provisions for the development requirements of Irish Water.

The Planning Regulator will be appointed by the Minister for Environment, Community and Local Government (currently Minister for Housing, Planning, Community and Local Government Simon Coveney TD). Their term should last no longer than five years.

PAC to review Public Sector severance pay

The PAC met last week with representatives from the Department of Public Expenditure and Reform (DPER) and the Central Bank. The Comptroller and Auditor General, Seamus McCarthy, was present at the committee meeting. On the agenda for the meeting was the recent report of the Office of the Comptroller and Auditor General, which examined severance payments made in certain public sector bodies.

The report outlines cases wherein certain severance payments were made without external consent by the parent Department or by the DPER. It also looks at the level of payments awarded as severance through six public service schemes.

The PAC meant to clarify what DPER intends to do regarding the lack of central guidance on severance payments. As Seamus McCarthy said at the meeting:

"The Department of Public Expenditure and Reform is responsible for policy on public sector pay and employment terms and conditions. Apart from the rules set out on specified approved severance schemes, the Department had not issued any general guidance to public sector entities on severance payments."

Seán Fleming, Committee Chairman, also said:

"Confidentiality clauses were a feature in every agreement underpinning the discretionary severance payments examined. [They want to clarify] that confidentiality clauses do not attempt to circumvent a statutory disclosure requirement or prevent employees from speaking out."

In response to this, DPER's Secretary General ensured that changes are in the pipeline. He said,

"Recently, text has been included in the revised code of practice for State bodies requiring disclosure of the aggregate value of severance payments and agreements in excess of €10,000. The text also calls on State bodies not to enter into confidentiality agreements which preclude them from disclosing details of settlements other than in exceptional circumstances and on foot of legal advice. The Department is currently considering what further elaboration on the existing guidance on severance may be necessary."

Obesity the target on new Government policy

Recent findings have shown that well over half – some 60% – of Irish adults are now either overweight or obese. Higher cases of obesity and overweight were found in lower social classes. In response to this, the Government have developed an Action Plan, and underpinning policy, that aims to tackle this growing problem.

The plan, entitled A Healthy Weight for Ireland: Obesity Policy and Action Plan 2016-2025, was launched last Thursday 22 September by Minister for Health Simon Harris TD. At the launch, the Minister said:

"Rising levels of overweight and obesity are placing an increasing burden on individuals and society and this represents one of the biggest public health challenges Ireland is facing today."

Among the sixty actions the Government intends to take, the Plan provides for the following ways to shrink the figures:

- A clinical lead for obesity in the HSE;
- A national nutrition policy;
- "No fry zones"; and
- Targeting of disadvantaged areas in health promotion.
