#### 2. Updates, decisions and approvals by Task Force

At the meeting, the Task Force:

- Welcomed new members Dr Lorraine Nolan, CEO Health Products Regulatory
   Authority; Ms Rachel Kenna, Chief Nursing Officer, Department of Health and Mr
   Derek McCormack, Expert in Cold Chain Logistics, as well as Deirdre Watters, Head of Communications, Department of Health, who will be in regular attendance.
- Reviewed progress on actions from previous meeting, noting completion of seven
  actions and progress on the remaining two (listed below), and agreed that the Task
  Force is on track to meet the 11 December deadline for submission of the COVID-19
  Vaccination Programme Strategy and Implementation Plan to the Taoiseach.
- 3. Considered vaccine updates from the HSE and HPRA, and agreed Sean Bresnan to liaise with the HPRA in respect of commissioning and validation requirements for ultra-low temperature (ULT) freezers.
- 4. Reviewed and agreed the finalised programme structure, including seven workstreams and the appointment of SROs for each, and noted that this integrates the work ongoing across the HSE and Department of Health.
- Acknowledged that the HSE has restructured the HSE Covid-19 Vaccination
   Implementation Team to align with specific workstreams within the Task Force work programme.
- 6. Noted that detailed discussions have been taking place with the National Immunisation Office (NIO), and agreed that Lucy Jessop, NIO, will be added to the National COVID-19 Vaccination Working Group.
- 7. Discussed key issues, including the required IT infrastructure, workforce planning and model of vaccination delivery, and agreed that:
  - a. A paper on cohort prioritisation will be advanced this week at NPHET. The ultimate decision on this matter will be taken by Government
  - A DPIA will be need to be prepared and the OGCIO suggested that GDPR issues be discussed in advance with the Office of the Data Protection
     Commissioner
  - c. The Working Group will identify any need for additional knowledge, understanding or resources in relation to key issues as soon as possible.

- 8. Held a broad discussion on communications, agreed the importance of widely communicating progress in respect of the vaccine approval process and the details of the Vaccination Programme, and agreed that this element of the Strategy will be delivered through and by the relevant Departments, Agencies, officials and clinicians as part of that plan.
- 9. Re-affirmed commitment to agile decision-making and flexibility of plan.
- 10. Agreed the next meeting of the Task Force will take place on 7 December at 14:00, and will focus on the Strategy and Implementation Plan.
